"Let Rule Nisi be issued calling upon the respondents to show cause as to why a direction should not be given upon the Respondents to constitute vacation Courts for Civil cases during Civil Court vacation of the subordinate judiciary in every December and/or such other of further order

of orders that may be passed as this Court may seem fit and proper. The Rule made returnable within 2(two) weeks from date"

"36. (1) The Government may invest either the powers of any Civil Court under this Act, by name or in virtue of office,

(b) After consultation with the High Court Division any officer serving in any part of the territories to which this Act extends and belonging to a class defined in this behalf by the Government.

2) Nothing in sections 4, 5, 6, 8, 10 or 11 applies to any officer so invested, but all the other provisions of this Act, shall, so far as those provisions can be made applicable, apply to him as if he were a Judge of the Court with the powers of which he is invested.
